



## Resource List – Training Volunteers Working With Youth Around Sex Awareness and Education

Youth in the child welfare system suffer unique vulnerability factors and are in heightened danger of participating in risk behaviors, particularly early and unsafe sexual behavior.

A recent report published by the National Campaign to Prevent Teen and Unplanned Pregnancy found that teens in the child welfare system were reporting sexual activity at almost twice the rate of their peers overall. Data from the National Survey of Child and Adolescent Wellbeing suggest that at least about one-third of 17-year-old girls in the system have experienced at least one pregnancy.

While being a young parent within the child welfare system is a real and difficult challenge that can result from risky sexual behavior, there is an even more expansive spectrum of severe outcomes, including exploitations such as prostitution and/or sexual slavery. Shared Hope International's *National Report on Domestic Minor Sex Trafficking* found that many of the victims recruited for the commercial sex market within the United States come from the child welfare system.

It is important for CASA volunteers to be aware and prepared for the challenges which may involve sexual behavior and/or sexual abuse or exploitation, and also to have access to appropriate resources that can provide guidance to the youth themselves. Several courses offered by Shared Hope International ranging from 40 minutes to two days. Training for adults working with vulnerable youth, insight into the particular vulnerability of youth in foster care and

homeless youth, and help for adults to identify and respond to prostituted youth. The 40-minute video packages are available for a \$40 contribution.
